• MacArthur's construction came in and dug a six-foot-wide trench on the outside of the build to put in retaining blocks. This was done because the walls started to cave in. Tuffy and his volunteers helped to spread gravel 6 inches thick the whole length of the building. The retaining blocks are 3x3x6 theses will be double stacked and be at ground level when completed. We are doing the same thing with the Chinook. Dons ford tractor loaned us a tractor to get the gravel close to the area and then the rest was done with a wheelbarrow.
