
Justin is a native of Alpena and now raises his 4 children with wife Mary by his side.

Eligibility

This competition is open to all Michigan artists 18 years of age or older. Entries can be in any medium, and all entries must be original works of the artist's own creation, and have been completed in the last 5 years. All art work must be framed or mounted and ready to exhibit. Besser Museum reserves the right to reject any work that cannot be properly displayed because of size, fragility, or any other reason that hinders display.

Entry Fee and Procedure

Each artist may submit up to three (3) entries for a single nonrefundable fee of:

> \$15 for Besser Museum Members \$25 for NON Besser Museum Members

Artist can choose from one of two different options to enter artwork:

Option 1

Bring artwork, entry fee, completed entry form, Jury notification form, and self-addressed stamped envelope to the Besser Museum. All pieces must have an Identification Form attached.

Option 2

Email completed entry form, along with high quality photos of artwork to JuriedArt@bessermuseum.org. You can submit payment through PayPal, with credit card by calling the museum at 989-356-2202, or by mailing a check to Besser Museum at 491 Johnson Street, Alpena, MI 49707.

Entry fee MUST be received for artwork to be juried.

Artwork must be able to enter the building through 4' x 8' doors if accepted.

The Besser Museum reserves the right to remove any work for any reason before the exhibition opens.

Deliveries/Entries and Pick-ups

Works must be delivered, or entered via email, between Monday, October 12, and Monday, October 19. Works requiring installation must be completed by the artist at the time of delivery. Works accepted via email entry must be delivered to the museum for the exhibition by October 27th.

Non-Accepted work brought to the museum may be picked-up between October 25-31, 2020.

Accepted work for the Juried Art exhibition may not be removed from the exhibition before Saturday, January 2, 2021. Artwork may be picked-up after the exhibit ends, between Saturday, January 2, and Friday, January 8, 2021.

Work can be delivered or picked-up only during open hours: Monday—Saturday, 10 am to 3 pm Sunday—12 pm to 3 pm

The Besser Museum does not sell exhibited artwork. We will provide artist contact information to potential buyers. Sold works are subject to the pick-up conditions stated above.
